I. Call to order

Chairperson Hartford calls the meeting to order.

II. Approval of the agenda:

1. Elect Chairperson and Vice Chairperson

3. Joe Stephenson and Working Classroom

Gabrielle Uballez, Rosalie Lopez and Joe Stephenson present their proposal for phase II of "La Corriente de Valle" Mural. G. Uballez explains that this summer is going to be known at Working Classroom as the "Summer of Murals" and Phase II of would be an excellent addition. J. Stephenson has been researching for the content of the mual and has met with Deb Jojola Curator of the Indian Pueblo Cultural Center. The timeframe for the mural will be 900 BC- 1598 with Coronado's arrival. The first phase of the mural starts with the arrival of Coronado. J. Stephenson will continue his research and is planning to meet with Ted Jojola at UNM school of Planning. B.Burk recommends involving Isleta Pueblo. G. Uballez mentions that they will be engaging youth from Rio Grande High School, South Valley Academy, Harrison Middle School and Native American Community Academy. The mural apprentices will be mid and high school students. Most likely the advanced (highschool) students from phase I will return to paint phase II. S. Diepen offers to help collect photographs of local petroglyphs as she is a member of a rock art group who photographs petroglyphs in the region. L. Korte suggests including La Salle's expedition of French explorers.

4. Family Ties Sculpture to be relocated from Youth Services Center to the North Valley Little League

N. Masland explains that the Family Ties Sculpture will be relocated from Youth Services Center to the North Valley Little League. The sculpture is of a family playing softball and would be better suited for the Little League. B. Burk, J. Grassham and S. Turung all state that they like the idea of relocating the sculpture and replacing it with a more appropriate piece of artwork. S. Hartford inquires about how a new piece would be selected for the Youth Services Center. She sees two options: one is to select an existing piece and another would be to commission a community based project much like Joe Stephenson's mural model. B.Burk states that he wants to make sure that the piece from YSC would be replaced.

5. Possible New Projects

- a. **Sculpture Call for existing artwork** S. Diepen has been suggesting this concept to the board for a while. B. Burk suggests having 3-4 sites in mind. The board in in favor of this concept. J Grassham suggests that the particulars are determined such as where, budget, scale, etc.
- b. **Rape Crisis Center** N. Masland met with the Executive Director of Rape Crisis Center and she is requesting a sculpture for the entry outside of the building. They are

- undergoing a rebranding and would like to invite the Arts Board to have one of their meetings at the center once the rebrand is complete.
- c. **Serenity Mesa Treatment Center-** L. Korte suggested a sculpture for the treatment center, perhaps the Arts Board could have a meeting on site to learn about the center. B. Burk suggest that both Centers be considered for sites for the Call for Existing Sculpture.
- d. New Project for the Youth Services Center discussed above.

Chairperson Hartford entertained a motion to recommend Fertile Fragments #3 and Fertile Fragments #4 by Alan Paine Radebaugh for purchase to the County Commission.
